

## Strategic Litigation under the CRPD Optional Protocol



The right to individual petition before the CRPD Committee plays a vital role in promoting respect for the rights of persons with disabilities and advancing a global body of progressive jurisprudence. When domestic mechanisms fail to

provide an effective remedy to an individual with disabilities, or where such remedies do not exist, victims can seek redress beyond the State. At the same time, the availability of remedies at the international level encourages the development of more effective domestic and regional systems for remedy and redress.

## **MDAC Optional Protocol Litigation**

In 2010 MDAC launched a project aimed at conducting litigation using the CRPD in domestic courts, and taking cases to the CRPD Committee. The project involves research into effective ways of litigating the CRPD with a specific focus on:

- Article 12 (Equal recognition before the law and right to legal capacity)
- Article 19 (Living independently and being included in the community)
- Article 24 (Education)

MDAC is partnering with lawyers and NGOs to litigate cases in European States that have ratified the Optional Protocol.

## **Litigation Workshop in Budapest**

MDAC is keen to ensure that the Optional Protocol mechanism is exercised to full effect and is running a litigation workshop in Budapest, Hungary, 23-25 September 2010. The workshop is

designed to equip lawyers with the specific skills and knowledge necessary to conduct successful CRPD litigation.

The workshop is being run by internationally renowned academics and practitioners in the field of mental health and disability law. Training in the fundamentals of strategic litigation and the CRPD will be complemented by specific sessions on how to argue CRPD provisions in domestic courts, recent trends in jurisprudence, and developing advocacy strategies following litigation outcomes.
